



**FUND OBJECTIVE & PRINCIPAL INVESTMENT STRATEGIES**

The ICON Long/Short Fund seeks modest capital appreciation. It uses a quantitative methodology to identify securities ICON believes are underpriced relative to value. It normally invests in equity securities of companies of any market capitalization and traded in U.S. markets. The Fund will generally take long positions in equity securities identified as undervalued and take short positions in equity securities identified as overvalued. Each long or short position will be determined by considering the tradeoff between the attractiveness of each position and its impact on the risk of the overall portfolio. This strategy may not be changed unless the Fund shareholders are given at least 60 days' prior notice.


