## FUND OBJECTIVE & PRINCIPAL INVESTMENT STRATEGIES

The ICON Natural Resources Fund seeks long-term capital appreciation. It uses a quantitative methodology to identify securities ICON believes are underpriced relative to value. It normally invests at least 80% of its net assets, plus any borrowings for investment purposes, in equity securities of companies with operations throughout the world that own, explore or develop natural resources and other basic commodities or supply goods and services to such companies. 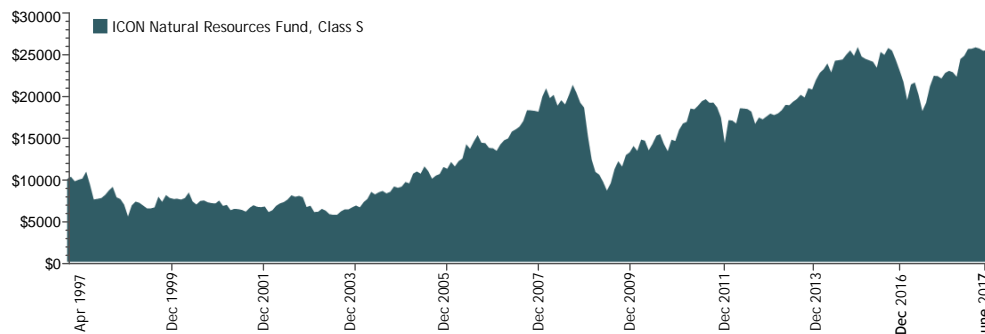
